Secretary's Report

The AAMHC met at the home of Terry and Stephanie Kinney near Oxford, IA on November 20th, 2010. There were 23 members present to enjoy pork and various side dishes provided by the members.

President Dale McSorley called the meeting to order at 12:36 pm.

The Secretary's report was read by Amy Dalsing.

The Treasurer's report was read by Stephanie Kinney.

Sue Johnson noted a correction to the meeting minutes read to include "some classes had to be rearranged due to the arrival of stock cars to the fair grounds in the afternoon that would be using the same track as the driving horses." The driving horses did not share the same track as the stock cars. The Secretary apologizes for the inaccuracy of this statement.

Old Business:

Dale McSorley brought up the possibility of donating all the proceeds or a set dollar amount from the fun show next year to the Vinton County Fair Grounds. Tom Dalsing made a motion to donate \$400 from the profits of the 2011 Fun Show to the Vinton County Fair Grounds next year. George Ronek seconded the motion and the motion passed.

The Vinton County Fair Grounds are reserved for the Fun Show next year for Sunday on Labor Day Weekend.

Sue Johnson reported that four judges have been contacted, Roger Eitel, Deb Hamilton, Kim Seipp and James Vernon. The contracts for Deb Hamilton and James Vernon have not been returned as of yet. Judges will cost \$225 less in fees than last year but travel may cost more.

Kirkwood Hotel was discussed as a possible hotel option to list in Premium Book but it was decided as too expensive to provide rooms for judges. The Clarion Hotel will be used again as the hotel for the judges.

New Business

Dale McSorley would like to see the Club purchase a trailer to hold equipment for the club (jumps, tables, chairs, etc.) but small enough a regular truck could pull it. Possible size of 6' x16" was mentioned. A committee was formed headed by Tom Dalsing and George Ronek to research possible prices and sizes. Dave Robinson, Tony Emerson and Joel Stohlmann also agreed to be on the committee.

Stephanie Kinney received a letter from the IRS that we need to report our profits from the gambling license and pay taxes on the proceeds.

Amy Price reported that approval from Jerald Sulky for the cart for the 2011 show raffle has been obtained.

Stephanie Kinney has researched an idea for a club clinic on halter and driving put on by Cory Hatfield in March. She has contacted 7A Ranch arena near Kent Park, Tiffin, IA would be available for \$200. The facility is heated to 48 degrees and temperature can be increased for a fee of \$50.00. Cory Hatfield charges \$100 per day, mileage, meals and lodging. He prefers to have the clinic on a Sunday. He would like no more than 50 horses in various stages of training in halter and driving. The club could provide food. They do have speakers for microphones in the arena. Free to club members and pay to non-members. The facility does not have stalls so all horses will have to jump out of trailer.

Tom Dalsing made a motion for the club to sponsor the clinic and it would be free to members and charge a \$25.00 per family fee (basically club membership) to non-members. The date to be determined in March and will be held at 7A Ranch. Dawn seconded the motion and the motion carried.

Dale McSorley asked for a volunteer for a club reporter to write up articles for the Journal publication. Amy Dalsing volunteered for the position.

The position of President and Treasurer are up for election.

The club asked Dale McSorley to remain as President. Tom Dalsing made a motion to have Dale continue as President of the Club. George Ronek seconded the motion and the motion passed.

Stephanie Kinney was asked to continue as Treasurer of the Club for another term. Joel Stohlmann made a motion to have Stephanie Kinney reelected as Treasurer and Mary Ronek seconded the motion and it passed.

Maureen Schroeder volunteered her residence for the next meeting on January 15th. More details to be provided soon.

Darwin Hopper made a motion to adjourn the meeting and the motion was seconded by Mary Ronek and the meeting was concluded.

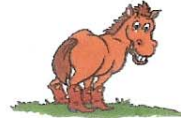

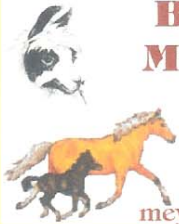

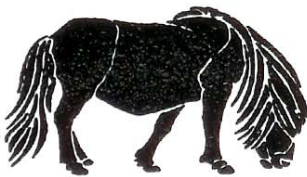
